From the total analysis of the details / explanation furnished by Sri Lall, on behalf of the assessee trust and analysis of enquiry report of DCIT, Rourkela Circle, Rourkela, it appeared that the activities of the assessee trust are charitable in nature.

In view of the above, the present application for registration u/s.12A is hereby granted. This order is effective w.e.f. 01.04.2013.
